1. Validation references and what they mean

Validation References

This document outlines the nature of each Data Validation Check. It should be used alongside the Data Validation Reports produced by Capita after processing each Standard or Manual Interface. This applies to both regular monthly updates and "ad-hoc" interfaces.

After an interface is loaded, Capita will generate a list of Data Validation Failures, which will be returned to the employer. It is the employer's responsibility to address each validation and return the updated validation report to Capita for reprocessing. Capita and the Scheme Manager will monitor the effectiveness of employers in managing and resolving their validation issues. Addressing your Data Validation Failures will ensure the quality of member data is maintained and enhance the overall member experience.

Below is a comprehensive table of validations performed during the interface process. You should use this list in conjunction with your validation report from Capita after processing your interface to address any errors and warnings. The table provides explanations for each validation. These errors and warnings must be addressed by you, the employer, or you must ensure you have a documented, auditable process with a third party to resolve them on your behalf.

Along with the description of each Data Validation Check and its reference number (DVC code), Capita has also documented the resolution for each validation failure. It is important to note that the resolution is a guide and not prescriptive. The actual solution will depend on the circumstances of the Data Validation Failure (DVF), the type of member, their working pattern, and the section of the scheme they belong to. You must work closely with the Interface team when resolving DVFs, as the documented resolution may not be appropriate in all circumstances. Incorrectly interfacing data can significantly impact member benefits and the member experience.

Validation references and what they mean

For software developers, we have provided pseudo-code detailing how the validation is triggered. You must use this information to ensure that data is correctly interfaced and does not fail validations. This will reduce data cleansing activities for you, the employer, or your third-party payroll providers. It will reduce costs and, most importantly, provide a much better experience for members, ensuring their benefits are paid correctly and with fewer delays due to quality issues.

You must work with the interface team to ensure that your payroll and HR system complies with these validation rules.

2. Action indicators on the Data Validation Report (DVR)

Each line of data in the Data Validation Report (DVR) includes a field called 'Action Indicator,' which instructs Capita on how to process the data record when the report is returned to the interface team. Before submitting the DVR to Capita, ensure that every record accurately reflects the intended processing instructions.

There are several options to choose from in the Action field:

- “A” – Add/Amend
- “C” – Confirm
- “D” – Delete

The available actions in the drop-down list will vary depending on whether the DVFs reported against the record are errors or warnings.

Errors

Errors are records that cannot be loaded into the Capita database because the data provided is invalid. To correct an error, amend the data in the report and set the action indicator to 'A' for add/amend. This instructs us to reprocess the data based on the corrected information in the Data Validation Report. If the data was sent in error and does not need correction, set the action indicator to 'D' for delete, indicating to Capita that the record should be disregarded

There are instances when a record fails data validation due to a related or 'secondary' record, even though the data in the primary record is correct. For example, a salary might be rejected because it falls outside a valid period of service. While the salary details are accurate, the absence of a corresponding service history causes the rejection. In such cases, mark the rejected record with an 'A' for add/amend. Additionally, provide the missing service history in the DVR's service history worksheet, also marked with an 'A'. If the new service history is not provided, the salary record will be rejected again.

There is no option to mark an error with a "C" for confirm. The confirm option is intended for records that fail with a warning, not those with an error. Its purpose is to inform Capita that the data provided is correct, even if it appears unusual. For example, a salary that falls outside the tolerance increase or decrease percentages can be confirmed. However, this is not possible for an error, as the data is incorrect and cannot be validated based on the information provided. Therefore, it is not possible to confirm an error.

Warnings

DVCs classified as warnings are those that appear unusual but are not impossible. Similar to records that generate errors, you can amend records with a warning and set the action indicator to "A" for amend.

If a record is interfaced incorrectly and generates a warning, you have the option to delete it from Capita’s database by setting the action indicator to "D" for delete. This action indicates that the data sent should not have been interfaced and removes it from the member record.

You can also confirm records that fail with a warning, indicating to Capita that you have assessed the data's validity and believe it is correct, even if it appears unusual. Capita will load records that fail with only a warning into our system and mark them as confirmed.

When a record fails a warning validation, you cannot change the "key fields." Altering the key fields will not replace the existing record in Hartlink; instead, it will create an additional record. If you need to change a "key field," you must select "D" on the action indicator, provide a new line of data, and then select "A" on the action indicator for the new information to be loaded into Hartlink.

Action indicators on the Data Validation Report (DVR)

New Records

The Data Validation Report is not a substitute for your regular monthly interface. However, there are instances when a new record needs to be added to the report. For example, if a salary breaches the tolerance check due to a missing salary, you should add the record to the Data Validation Report and set the action indicator to "A." Ensure that the Record Reference, Error or Warnings, and DVF No. fields are left blank.

You must not:

- **Sort the worksheets:** The order of the data is crucial and must not be altered.
- **Insert new rows:** Add any new data records to the next available row in the worksheet, without inserting them between existing rows.
- **Change key data fields for records with a warning.**
- **Change the column order of the worksheets.**
- **Change any headings.**
- **Change column/cell formats.**
- **Delete rows:** Only delete rows using the “D” action indicator.
- **Send “unactioned” rows to Capita**
- **Change the drop-down lists in the worksheets.**

Capita has secured the Data Validation Report to prevent unauthorized changes, and these restrictions must not be bypassed. Altering the report's structure can lead to data corruption. If you need a copy of the report, please contact the interface team.
